## ***The 6<sup>th</sup> London Summer School in Intellectual History***

The London Summer School in Intellectual History, run jointly by University College London (UCL) and Queen Mary, University of London (QMUL), is a rare opportunity for graduate students to acquire further training in the discipline and its different methodologies. Taking place at UCL from **4 to 7 September 2017**, the 6<sup>th</sup> Summer School in Intellectual History will include:

- Special workshops
- Masterclasses
- Feedback on current research
- Advice on writing and publishing
- Discussion of newly published work in intellectual history

This year's keynote lectures will be delivered by Prof. [Ann Thomson](#), Professor of European Intellectual History at the European University Institute, and the other by Prof. [Quentin Skinner](#), the Barber Beaumont Professor of the Humanities at Queen Mary, University of London.

The discussions will be led by members of faculty from colleges across the University of London, and from overseas. This year's Summer School will feature masterclasses led by Dr. Angus Gowland (UCL), Dr. Maurizio Isabella (QMUL), Dr. Avi Lifschitz (UCL), and Prof. Georgios Varouxakis (QMUL); a panel discussion on methodology in the study of intellectual history, with Dr. Sanja Perovic (King's College London), Dr. Mark Philp (University of Warwick), Dr. Arnault Skornicki (Université Paris Nanterre), and Prof. Ann Thomson (EUI); a panel discussion on publishing in intellectual history, with Prof. Richard Bourke (QMUL), Prof. Julian Hoppit (UCL), Ben Tate (Princeton University Press); and a discussion of a recently published book by Dr. Or Rosenboim (University of Cambridge). ### **Student Presentations**

The Summer School presents a rare opportunity for graduate students of varying backgrounds to discuss their research with peers and with members of faculty from across the University of London. Participants are asked to prepare a five-minute presentation on their research, as well as an abstract or handout to be pre-circulated among all participants and members of faculty, in order to facilitate discussion.

These presentations will take place in two sessions, on at 13:30—16:30 on Tuesday, 5 September, and Wednesday, 6 September. Participants will have been informed in advance about the sessions in which they will be presenting.

### **Masterclasses**

Summer School participants will attend two masterclasses based on set reading, one on Tuesday, 5 September, and the other on Wednesday, 6 September. Participants will be divided into two groups, broadly according to their research interests; each group will attend a masterclass, on either Tuesday or Wednesday, led by a specialist in the field.

In addition to this thematic masterclass, all participants will attend one focused on methodology in the study of intellectual history. This masterclass will run on both Tuesday, 5 September, and Wednesday, 6 September; the two groups of participants will attend them in turn. Participants will have already been informed of their groups, schedules, and required reading. Please refer to the programme, or to prior correspondence concerning the masterclasses if the above is unclear.

### **Book Discussion**

The Summer School programme includes a book discussion, where participants, having read a recent publication in intellectual history, discuss it with the author. This year, we are delighted to have Dr. Or Rosenboim of the University of Cambridge to present and discuss her recently published book, *The Emergence of Globalism: Visions of World Order in Britain and the United States, 1939-1950* (Princeton, NJ: Princeton University Press, 2017). In particular, participants have been invited to read the introduction, as well as Chapters Four and Five of Dr. Rosenboim's book, alongside earlier versions of these sections, so as to inform a discussion on how to write a book based on one's doctoral thesis.
